

# Waiver of Claims and Release of Liability

I, the undersigned Participant, voluntarily request to participate in the Event identified above together with my dog or dogs (collectively my “Dog”).

I acknowledge that the activities of the Event can be dangerous and could involve the risk of serious injury, death, or damage to me or my Dog. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees (as defined below) or others, and assume full responsibility for my and my Dog’s participation in the Event.

In consideration for allowing me to participate in the Event with my Dog, I hereby for myself, my heirs, executors, and administrators or anyone acting on my behalf, waive, release, covenant not to sue, and fully defend, indemnify, hold harmless, and discharge Mile High Dachshunds Rescue, its directors, officers, employees, partners, representatives, and agents, and any sponsors, suppliers, independent contractors and all other individuals and entities in any way assisting or connected with this Event (collectively the “Releasees”) from any and all claims, demands, causes of action, losses, damages, liabilities, costs, and expenses (including reasonable attorney’s fees) of any kind arising out of my or my Dog’s participation in this Event, regardless of who causes the injury, death, or damage sustained and regardless of whether based on fault or negligence or otherwise.

I hereby consent and grant permission to the use of my and/or my Dog’s name, likeness, image, voice, recording, biographical information, and/or other identification by the Releasees for any purpose, worldwide and in perpetuity, in any medium now known or hereafter devised, without a right to prior review or approval of such use and without compensation or any additional consideration due or owing to me.

I HAVE READ THIS WAIVER OF CLAIMS AND RELEASE OF LIABILITY (THE “WAIVER”) AND I AM COMPETENT TO SIGN IT. I UNDERSTAND THAT BY SIGNING THIS WAIVER I AM GIVING UP MY LEGAL RIGHT TO SUE THE RELEASEES AND/OR TO SEEK COMPENSATION FROM THE RELEASEES FOR ANY INJURIES OR DAMAGES THAT I OR MY DOG MAY INCUR AS A RESULT OF OR INCIDENT TO OR OTHERWISE IN CONNECTION WITH MY AND MY DOG’S PARTICIPATION IN THE EVENT. I HAVE READ THIS WAIVER AND UNDERSTAND ITS CONTENTS AND AGREE TO ALL OF ITS TERMS.
